## AGREED ORDER

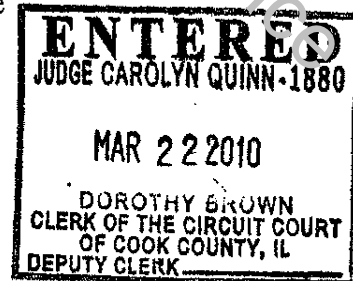
This cause having come on to be heard on the Stipulation of Plaintiff in this action E.S. Windows, Inc. and the Court being fully advised in the premises,
