4. That Affiant is not a VESSEL, as a VESSEL is documented under Chapter 121 of TITLE 46, UNITED STATES CODE, or as a VESSEL IS NUMBERED as provided in Chapter 123 of said TITLE, Affiant Mark Alan of the Parker family is not the STRAWMAN; and
5. That Affiant hereby, Cancels an presumed election made by the UNITED STATES GOVERNMENT or any AGENCY or DEPARTMENT thereof, that I am or ever have been a CITIZEN/citizen, ALIEN CITIZEN or RESIDENT of any TERRITORY, POSSESSION, INSTRUMENTALITY or ENCLAVE, under the Sovereignty or exclusive JURISDICTION of the UNITED STATES, as defined in The Constitution for The United States of America in Article I, Sec. §8 CL 17 and Article IV, Sec §3, CL 2.
