D. Amendment No. 2. Transfer of Parking Space Limited Common Element P-25.

- 1. Nguyen and Hoang are the legal owners of Edgewater Glen Unit C2. Edgewater Glen Parking Space Limited Common Element P-25 has been assigned and is appurtenant to Unit C2.
- 2. Nguyen and Hoang are desirous of assigning Parking Space Limited Common Element P-25 back to the Declarant, and Declarant is desirous of effecting such assignment.
- 3. Such a transfer is permitted pursuant to Section 26 of the Act and Section 3.6(c) of the Declaration.
- 4. Such a transfer will not change or affect the parties' respective percentage interest in the Common Elements for the Units owned by the parties.
- 5. There is no other unit owner who has any right to use Parking Space Limited Common Element P-25.

BASED ON THE ABOVE, THE DECLARATION IS AMENDED AS FOLLOWS:

- 1. The above recitals are incorporated into this Amendment.
- 2. Pursuant to Section 26 of the Act and Section 3.6(c) of the Declaration, the undersigned consent and agree that the Declaration is hereby amended to provide that all right, title and interest in and to Edgewater Glen Parking Space Limited Common Element P-5 is hereby assigned and made appurtenant to Edgewater Glen Unit C2.
