All doctor, hospital, funeral bills, etc. have been paid and there were no Old Age Medicaid or Public Assistance advancements.



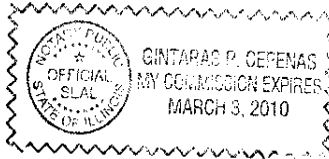
