**UNOFFICIAL COPY****SPECIAL POWER OF ATTORNEY**

THIS IS A MILITARY POWER OF ATTORNEY PREPARED AND EXECUTED PURSUANT TO TITLE 10, UNITED STATES CODE, SECTION 1044B, BY A PERSON AUTHORIZED TO RECEIVE LEGAL ASSISTANCE FROM THE MILITARY SERVICES. FEDERAL LAW EXEMPTS A MILITARY POWER OF ATTORNEY FROM ANY REQUIREMENT OF FORM, SUBSTANCE, FORMALITY OR RECORDING THAT IS PROVIDED FOR POWERS OF ATTORNEY BY THE LAW OF ANY STATE, COMMONWEALTH, TERRITORY, DISTRICT, OR POSSESSION OF THE UNITED STATES. FEDERAL LAW SPECIFIES THAT A MILITARY POWER OF ATTORNEY SHALL BE GIVEN THE SAME LEGAL EFFECT AS A POWER OF ATTORNEY PREPARED AND EXECUTED IN ACCORDANCE WITH THE LAWS OF THE JURISDICTION WHERE IT IS PRESENTED.

KNOW ALL PERSONS, that I, JASON R. SMITH, a legal resident of ILLINOIS and presently residing at 6600 PEACEFUL ST CLINTON MD 20735, desiring to execute a SPECIAL POWER OF ATTORNEY, do hereby appoint JANE T. SMITH whose address is 5842 SOUTH HOMAN STREET CHICAGO IL 60629, as my Attorney-in-Fact to act as follows, GRANTING unto my said Attorney full power to:

Purchase, enter upon, and take possession of property located at 6143 SOUTH MAJOR AVE CHICAGO IL 60638, together with all improvements thereon, in my name and for an amount he/she, in the exercise of sound judgment, deems best. Sign any notes, mortgages, applications for financing and insurance policies, and to do any and all acts necessary for the purchase of this property, to include all actions necessary to secure a loan for the purchase of this property.

**TERMINATION:** This Power of Attorney shall become null and void the 23<sup>rd</sup> day of February, 2011 unless I should become incapacitated; in that case, it shall remain in effect until revoked by me.


