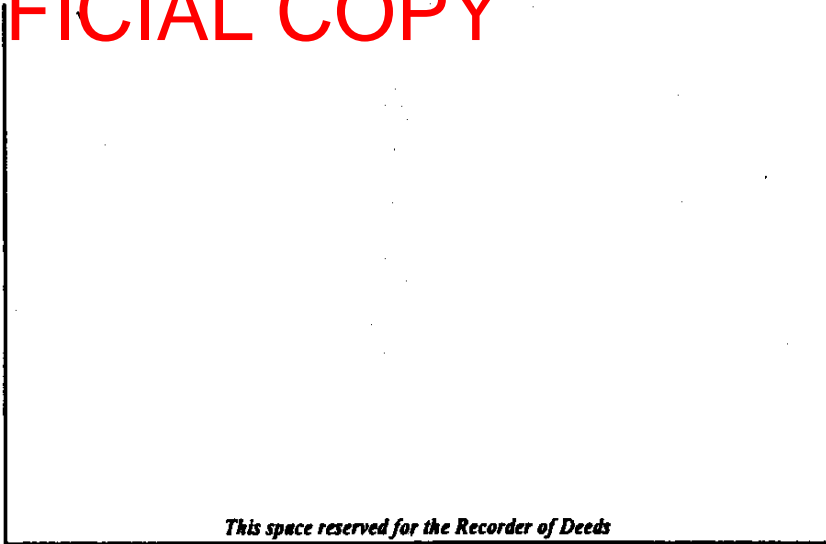


ORDER OF PERMANENT INJUNCTION
