PLEASE TAKE NOTICE that the judgment creditor, CITY OF CHICAGO, through its attorneys, BAKER, MILLER, MARKCER & KRASNY, LLC, has registered an administrative judgment with the Circuit Court of Cook County, Illinois, as follows:
