The Claimant, Four Province Masonry, Inc. ("Claimant"), of Chicago, Illinois, hereby files its Notice and Claim for Lien against the following:

On and before September 1, 200%, Owner owned the premises described below ("the premises), and Owner entered into a contract with Contractor, for the Contractor to provide construction labor and materials, for the construction of a multi-story, multi-unit building upon the premises ("the construction project"). Owner knowingly permitted and approved Contractor to enter into subcontracts with others, including Claimant, for the construction project.

The premises are described as follows:

Lot 18, 19 and the South 1 Foot of Lot 20 in Block 34 in Wolcott's addition to Chicago in Section 9, Township 39 North, Range 14 east of the third principle meridian, in Cook County, Illinois.

This real estate and all improvements upon it are referred to as "the premises".

The Owner continues to own the premises to date.

On or about September 1, 2008, Contractor entered into a subcontract with the Claimant (the "Contract"), for the Claimant's provision of masonry-related labor and equipment for installation of masonry, for the construction project, and additional labor and material for the construction project in an upon the premises, for \$200,000.00. Contractor ordered changes to the Contract in the amount of \$6,300.00. The total Contract amount including the changes was \$206,300.00.

The Owner consented to or knowingly approved of the Contract. Alternatively, the Claimant provided its labor and materials with the Owner's knowledge and consent. Alternatively, the Owner specifically authorized or knowingly permitted Contractor to enter into contracts for the construction project.

On June 2, 2010, Claimant completed all required by the Contract, including all changes. Contractor is entitled to credits in the amount of \$165,600.00, leaving due, unpaid, and owing to Claimant, after completion of the Contract (including all changes) and after allowing all credits, the balance of forty thousand, seven hundred dollars (\$40,700.00), for which, with interest, the Claimant claims a lien on the premises and on the monies or other considerations due or to become due to Contractor from the Owner under said contract between Contractor and Owner.
