This First Amendment (the "First Amendment") to the Declaration of Condominium Ownership for 1414 West Chicago Condominiums (the "Declaration") is made and entered into this 22 day of June, 2010 by the Board of Directors of the 1414 West Chicago Condominiums Association (the "Board").

WHEREAS, pursuant to the Declaration, which was recorded on March 31, 2009 with the Cook County Recorder of Deeds as Document # 0909045109 the Board administers the condominium property located at 1414 West Chicago Avenue, Chicago. Illinois 60622, which is legally described on Exhibit "A" attached to this First Amendment;

WHEREAS, the Board and the Unit owners desire to amend the Declaration to correct the definition of "Association" to omit reference to the fact that the Association is an Illinois not-for-profit corporation;

WHEREAS, Article XIII, Sub-Section A(2) of the Declaration states that the provisions of the Declaration may be modified by a written instrument that (i) is signed and acknowledged by not less than three-fourths (3/4) of the total ownership of the Common Elements (i.e. the Unit owners); (ii) has been sent by certified mail to all lien holders of record having a bonafide lien against a Unit; and (iii) contains an affidavit by the Secretary of the Association certifying that all lien holders have been so notified; and

WHEREAS, the First Amendment set forth below has been approved by the Board and at least three-fourths (3/4) of the Unit owners and has been mailed to all lien holders as provided in the Certification of the Secretary attached hereto as Exhibit "B".

NOW, THEREFORE, Article I of the Declaration is hereby amended as follows:

- The definition of Association in sub-section I(b) is hereby deleted and replaced with the 1. following:
 - "Association' means 1414 WEST CHICAGO CONDOMINIUMS ASSOCIATION, which is responsible for the overall administration of the Property in accordance with the Declaration and the Act, acting pursuant to the Bylaws through its Board of Directors. The Association has not been incorporated."
- All other provisions of the Declaration shall remain in full force and effect. 2.
