NOTICE OF LIEN FOR COSTS OF DEMOLITION

NOW COMES Mary Dankowski, Director of Finance of the Village of Park Forest, Cook and Will Counties, Illinois ("Village"), and Jerry Martin, official for the Village of Park Forest responsible for enforcing the building code, and pursuant to section 11-31-1(e) of the Illinois Municipal Code, 65 ILCS 5/11-31-1(e), who are hereby authorized on behalf of the Village to bring this lien and state under oath as follows:

- 6. The Village incurred costs and attorney fees in this matter in the amount of \$1,370.02 on the dates an in the amounts indicated on the Invoice of Robbins, Schwartz, Nicholas, Lifton & Taylor, Ltd. attached hereto as Exhibit A.
