**AMENDED
AFFIDAVIT OF HEIRSHIP**

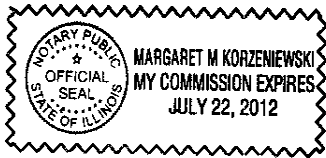
