PLEASE TAKE NOTICE that the judgment creditor, City of Chicago, through its attorney, Arnold Scott Harris P.C., Special Assistant, Corporation Counsel, has registered an administrative judgment with the Circu t Court of Cook County, Illinois as follows:

On SEE EXHIBIT "A" administrative money judgments were rendered in the City of Chicago – Department of Administrative Hearings ("DAH"), in favor of the plaintiff, City of Chicago, and against the defendant(s), ADOLFO LOPEZ. Pursuant to Illinois law, 65 ILCS 5/1-2.1-7 and 5/1-2.1-8, the defendant(s) either: (a) failed to seek administrative review within thirty-five (35) days of the administrative judgment; (b) sought administrative review and failed to overturn the administrative judgment; or (c) sought administrative review but failed to seek or obtain a stay of the administrative money judgment. Accordingly, bursuant to 65 ILCS 5/1-2.1-8(c), the DAH judgment may be enforced in the same manner as a money judgment entered by a court of competent jurisdiction. The DAH judgment against the defensan(s), ADOLFO LOPEZ, is in the amount of \$1210.00. Interest accrues on the administrative judgment at the rate of nine (9) percent per annum from the beginning of the thirty-fifth (35th) day after the City of Chicago – Department of Administrative Hearings rendered its administrative judgment.
