DECLARATION OF ASSIGNMENT AND TRANSFER OF STORAGE LOCKER

AMENDMENT 19 THE DECLARATION OF CONDOMINIUM

FOR

(hereinafter the "Transferee") as legal title owner of Condominium
Unit(s) (hereinafter, the "Unit") in the aforementioned Condominium

WHEREAS, Transferor, has the right to the exclusive use and possession, as a Limited Common Element, of Storage Space Space (hereinafter, the "Storage Space"), which is located in the Condominium, and which is legally described on Exhibit A attached hereto, and

WHEREAS, Transferee, as the owner of the aforesaid Unit, which is legally described on Exhibit B attached hereto, desires to acquire the right to the exclusive use and possession of the Storage Space, and

WHEREAS, Transferor and Transferee desire that the right to the exclusive use and possession of the Storage Space be transferred and assigned to Transferee as the owner of the Unit.

NOW, THEREFORE, pursuant to the terms of the Condominium Property Act of the State of Illinois and of the Declaration of Condominium for The Private Residences at Ontario Place, a Condominium, recorded in the Office of the Cook County Recorder of Deeds on October 28, 2006, as Document No. 0530118066, as amended from time to time, the parties agree as follows:

1. Transferor hereby assigns to Transferee, as owner of the Unit, the right to the exclusive use and possession the Storage Space, as a Limited Common Element, which right shall be appurtenant to and serve exclusively said Unit. No other Unit Owners have any right to the use or possession of the Storage Space.

The right to the use and possession of the Storage Space being transferred and assigned hereunder is subject to: (a) the Condominium Property Act of the State of Illinois and the Municipal Code of the City of Chicago; (b) the Condominium Declaration and any amendments thereto; (c) such rules and regulations as the Board of Directors of The Private Residences at Ontario Place Condominium Association (hereinafter, the "Association") may from time to time prescribe; (d) existing leases, liens and encumbrances encumbering the Unit to which the Storage Space is assigned by this Declaration; and (e) the right of the Association to run and maintain utility lines and service through the Storage Space and the area in which the Storage Space is located as necessary for the Association.
- 3. A copy of this Declaration of Assignment and Transfer of Storage Space and Amendment to Declaration of Condominium shall be lodged with the Board of Directors of The Private Residences at Ontario Place Condominium Association.
- 4. To the best of the knowledge of the parties hereto, said transfer of the right to the exclusive use and possession the Storage Space to the Unit does not change the parties respective percentage ownership in the common elements.
