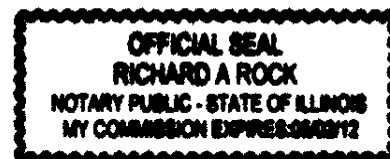
That the deceased died July 15, 2009, as evidenced by a copy of the death certificate of the deceased attached hereto;

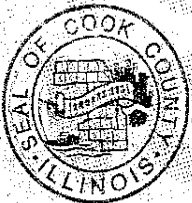
