### FOURTH LOAN MODIFICATION AGREEMENT

THIS FOURTH LOAN MODIFICATION AGREEMENT (the "Agreement") is made and entered into as of the 10<sup>th</sup> day of June, 2010 by and among MB FINANCIAL BANK, N.A. ("Lender"), 3415 N. SOUTHPORT LLC, an Illinois limited liability company ("Borrower"); 3447 N. SOUTHPORT LLC, an Illinois limited liability company ("Nominal Party"); and EVAN OLIFF and THOMAS MORABITO (herein individually and collectively called "Guarantors").

### RECITALS:

- A. Borrower is the owner of certain real estate (the "3415 Premises") commonly known as 3415-21 North Southport Avenue, which is located in the City of Chicago, County of Cook, State of Illinois and more particularly described on Exhibit A attached hereto and made a part hereof.
- B. Lender has heretofore made a mortgage loan (toe "Loan") to Borrower in the stated principal sum of Two Million Seven Hundred Seventy Five Thousand Dollars and No Cents (\$2,775,000.00).
- C. The Loan is evidenced and secured by the following clocuments in favor of Lender (hereinafter defined and, together with all other documents evidencing, securing or otherwise governing the Loan, collectively referred to as the "Loan Documents") each of which is dated as of June 10, 2008 unless otherwise stated:
  - (i) Note (the "3415 Note") made by Borrower in the stated principal sum of Two Million Seven Hundred Seventy Five Thousand Dollars and No Cents (\$2,775,000.00);
    - (ii) Guaranty (the "Guaranty") made by Guarantors in favor of Lender;
  - (iii) Mortgage (the "3415 Mortgage") made by Borrower to Lender encumbering the 3415 Premises and the improvements thereon and all other property, assets and collateral therein described, which 3415 Mortgage was recorded in the Office of the Recorder of Deeds of Cook County, Illinois (herein called the "Recorder's Office") as Document No. 0816533252;

- (iv) Mortgage (the "3447 Mortgage") made by Nominal Party to Lender as of February 13, 2008, encumbering the property commonly known as 3447-49 North Southport Avenue, Chicago, Illinois ("3447 Premises") and the improvements thereon and all other property, assets and collateral therein described, which 3447 Mortgage was recorded in the Office of the Recorder of Deeds of Cook County, Illinois (herein called the "Recorder's Office") as Document No. 0804641087;
- (v) Assignment of Rents and Leases made by Borrower to Lender, which was recorded in the Recorder's Office as Document No. 0816533253;
- (vi) Security Agreement made by Borrower, as debtor, to Lender, as secured party,
- (vii) Undated Uniform Commercial Code Financing Statements made by Borrower, as debtor, to Lender, as secured party, which were recorded in the Recorder's Office as Document No. 0816533255 and filed with the Illinois Secretary of State as Document No. 13347948;
- (viii) Environmental Indemnity Agreement made by Borrower and Guarantors, as indemnitors, to Lendel:
- (ix) Loan Modifica io 1 Agreement dated March 10, 2009 by and among Lender, Borrower and Guaranto's which was recorded in the Recorder's Office as Document No. 0908339045;
- (x) Second Loan Modification Agreement dated May 13, 2009 by and among Lender, Borrower and Guarantors which was recorded in the Recorder's Office as Document No. 0918118002, and
- (xi) Third Loan Modification Agreement dated August 13, 2009 by and among Lender, Borrower, Guarantors and Nominal Party which was recorded in the Recorder's Office as Document No. 0923016059.
- D. The Maturity Date of the 3415 Note is June 10, 2010.
- E. The unpaid principal balance of the 3415 Note as of June 10, 2010 is \$2,775,000.00.
  - F. Lender and Borrower have agreed to extend the Maturity Date of the Loan.
  - G. The agreements of the parties are set forth herein and limited to this Agreement.

#### **AGREEMENT**

NOW, THEREFORE, for valuable considerations, the receipt and sufficiency of which are hereby acknowledged, it is agreed as follows:

- 1. Recitals. The recitals hereto are incorporated herein by reference as fully and with the same force and effect as if each and every term, provision and condition thereof was specifically recited herein at length.
- 2. **Definitions.** All capitalized terms herein not otherwise defined shall have the same meanings as in the 3415 Note, 3415 Mortgage and in the other Loan Documents.
- 3. Amendment to 3415 Note. The 3415 Note is modified to extend the Maturity Date to September 10, 2010.
- Continued Priority. In the event that, by virtue of any of the terms, conditions and provisions of this Agreement, a lien or other property interest in the Premises otherwise junior in priority to the liens created by the Loan Documents shall gain superiority over the liens created by the Loan Documents, this Agreement shall, nunc pro tunc, be null and void without further action of the parties hereto to the fullest extent as if it had never been executed, to the end that the priority of the Loan Documents shall not be impaired.
- 5. Extension Fee. Borrower shall pay Lender an extension fee in connection with this Agreement in the amount of Two Thousand Five Hundred Dollars and 00/100 Cents (\$2.500.00) no later than Borrower and Guarantors' execution and delivery of this Agreement to Lender.
- 6. Non-Waiver. In the event Lender shall at any time or from time to time disburse portions of the Loan without Borrower first sais ying all conditions precedent set forth herein or in the Loan Documents, Lender shall not thereby be deemed to have waived its right to require such satisfaction of the same or other condition as a condition precedent to its obligations to make further disbursement of the Loan.
- 7. Ratification. The Loan Documents are hereby ratified, confirmed and approved and are and shall remain in full force and effect pursuant to the terms and conditions set forth therein, except to the extent otherwise expressly modified hereby.

Each of the Loan Documents is hereby modified and amended so that all reference to such documents shall be deemed to be a reference to the Loan Documents as lereby modified and amended.

- 8. <u>Joinder of Guarantors</u>. Notwithstanding anything to the contrary contained herein Guarantors have entered into this Agreement for the limited purpose of ratifying and confirming Guarantors' obligations under the Guaranty and to acknowledge that the Guaranty and the other Loan Documents, as amended hereby, remain in full force and effect.
- 9. No Defenses, Counterclaims. Borrower and Guarantors hereby represent and warrant to, and covenant with, Lender that, as of the date hereof, (a) Borrower and Guarantors have no defenses, offsets, or counterclaims of any kind or nature whatsoever against Lender with respect to the 3415 Note or any of the Loan Documents, or any action previously taken or not taken by Lender with respect thereto or with respect to any security interest, encumbrance, lien or collateral in connection therewith to secure the liabilities of Borrower and Guarantors, and (b)

that Lender has fully performed all obligations to Borrower and Guarantors which it may have had or has on and as of the date hereof.

- Without limiting the generality of the foregoing, Borrower and Release. 10. Guarantors, on their own behalf and on the behalf of its representatives, trustees, affiliated and related entities, successors and assigns (hereinafter collectively referred to as the "Borrowing Group") hereby waive, release and forever discharge Lender, and its officers, directors, subsidiaries, affiliated and related companies or entities, agents, servants, employees, shareholders, representatives, successors, assigns, attorneys, accountants, assets and properties, as the case may be from and against all manner of actions, cause and causes of action, suits, debts, sams of money, accounts, reckonings, bonds, bills, specialties, covenants, contracts, controversics, agreements, promises, obligations, liabilities, costs, expenses, losses, damages, judgments, executions, claims and demands, of whatsoever kind or nature, in law or in equity, whether known of unknown, whether or not concealed or hidden, arising out of or relating to any matter, cause or thing whatsoever, that any of the Borrowing Group, jointly or severally, may have had, or now have or that may subsequently accrue against the Lender by reason of any matter or thing whatsoever arising out of or in way connected to, directly, or indirectly, the Loan Documents through the date hereof. Borrower and Guarantors acknowledge and agree that Lender is specifically relying upon the representations, warranties, covenants and agreements contained herein and that such representations, warranties, covenants and agreements constitute a material inducement to enter into this Agreement.
- 11. **No Custom.** This Agreement shall not establish a custom or waive, limit or condition the rights and remedies of Lender under the Loan Documents, all of which rights and remedies are expressly reserved.
- 12. <u>Captions, Counterparts</u>. The captions used herein are for convenience of reference only and shall be deemed to limit or affect the construction and interpretation of the terms of this Agreement. This Agreement may be executed in any number of counterparts or in any number of counterpart signature pages, all of which together shall be deemed the original and constitute one and the same instrument.
- the respective rights and obligations of the parties hereto, shall be governed by and construed according to the internal laws of the State of Illinois (without regard to its conflict of laws principles). The parties agree and stipulate that this Agreement was executed delivered and accepted by Lender in Illinois, all payments shall be made to Lender and accepted by Lender in Illinois, and that Illinois has a substantial relationship to the parties and to the underlying transaction contemplated by this Agreement. Notwithstanding the foregoing, the parties agree that in the event of any action by the Lender in enforcing any of the Loan Documents, regardless of where the collateral is located, the parties agree and intend that the laws of the State of Illinois shall govern the right of Lender to collect or obtain a judgment and each party hereto consents to the jurisdiction of any federal or state court located in Cook County, Illinois. If any provision of this Agreement is held invalid or unenforceable, the remainder of this Agreement will not be affected thereby and the provisions of this Agreement shall be severable in any such instance.
