- 13. Notices. Any notice to Borrower provided for in this Security Instrument shall be given by delivering it or by mailing it by first class mail unless applicable law requires use of another method. - E "BORROWER'S RIGHT TO RENSTATE" DELETED. Section 19 is deleted.
