The Board and the Unit Owners desire to further amend the Declaration to protect and preserve the quality of the air shared through the building ventilation system by prohibiting cigarette, cigar, pipe or any other smoking in the building, including in the Units. Smoking will be permitted in Units only if the Unit Owners limit smoking to a single room which has been equipped, to the Board's satisfaction, with a self-contained air treatment system which prevents smoke from infiltrating the building shared ventilation system.

Article XV of the By-Laws, Exhibit C to the Amended and Restated Declaration provides that the provisions of the By-Laws may be amended by resolution of the Board recommending such Amendment or modification to the Unit Owners, and by the vote or written consent thereto by Voting Members holding two-thirds (2/3) of the total Undivided Interests. All Amendments shall be signed by the President and recorded.

The Amendment set forth below has been recommended by the Board and approved by the vote or written consent of Unit Owners having, in the aggregate, at least two-thirds (2/3) of the total vote, pursuant to the Secretarial Certification attached hereto, made a part hereof, and marked as Exhibit A.

NOW THEREFORE, the Declaration is hereby amended as follows: Exhibit C, By-Laws, Article IX, Paragraph 9.1(d) is amended to read:

"(d) No dangerous, unlawful, noxious or offensive activity shall be carried on in any Unit or in the Common Elements, nor shall anything be done therein either willfully or negligently, which may become an annoyance or nuisance to the other Unit Owners. Without limiting the generality of the foregoing, cigarette, cigar, pipe or other smoling shall be prohibited in the interior Common Elements, interior Limited Common Elements and in the Units. However, smoking will be permitted in Units if rescricted to a single room within the Unit that has been equipped with an Association approved self-contained air treatment system which prevents smoke from intiltrating the Building shared ventilation system."
