- 4. The quantity of water for which this lien is filed is exproximately 30 thousand cubic feet.
- 5. The amount due for water service is \$941.68.
- 6. Sewer service was furnished to the herein described property by the Claimant, at the rate provided by Title 3, Chapter 12 of the Code.
- 7. The amount due for sewer service is \$374.07.
