Interest will be charged on the Unpaid Principal Balance at yearly rate of 5.25%, beginning July 1, 2010. The Borrower promises to make monthly payments of principal and interest of U.S. \$427.89, beginning on the 1st day of August, 2010, and continuing thereafter on the same day of each succeeding month until principal and interest are paid in full.
