My agent shall be entitled to reasonable compensation for services rendered as agent under this power of attorney.



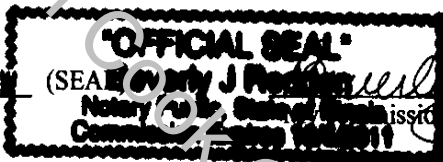

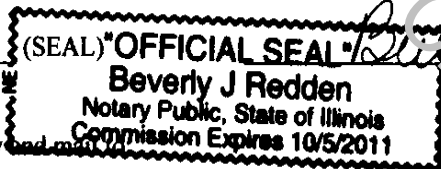
