## NOTICE OF LIEN

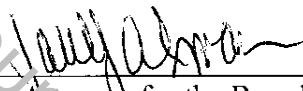

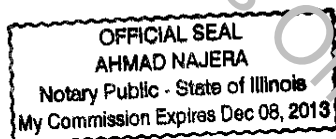

The balance due to the Association for said amounts, unpaid and owing pursuant to the aforesaid Declaration and law, after allowing all credits, is the sum of \$25,896.41 through August 1, 2010. Each monthly assessment, parking and late charge thereafter are in the sum of \$752.43, \$55.07 and \$150.00 per month, respectively, or such other assessments and charges which may be determined by the Board of Directors. Said assessments, together with interest, late charges, costs and reasonable attorneys' fees constitute a lien on the aforesaid real estate.
