Stanek, M.A., LCPC, S.C. on Count I of Plaintiff's Verified Complaint in the amount of \$33,841.57, which sum consists of unpaid principal (\$29,613.69), accrued interest thereupon through August 10, 2010 (\$2,190.31), applicable late charges (\$153.57), reasonable attorneys' fees (\$1,500.00) and allowable costs (\$384.00).
2. Default judgment is entered in favor of Plaintiff JPMorgan Chase Bank, N.A. and against Defendant Kenneth J. Stanek on Count II of Plaintiff's Verified Complaint in the amount of \$33,841.57, which sum consists of unpaid principal (\$29,613.69), accrued interest thereupon through August 10, 2010 (\$2,190.31), applicable late charges (\$153.57), reasonable attorneys' fees (\$1,500.00) and allowable costs (\$384.00).
