SEVENTEENTH AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP FOR SONO WEST CONDOMINIUM

This Seventeenth Amendment to Declaration of Condominium Ownership for SoNo West Condominium ("Seventeenth Amendment") is made this 127 day of August, 2010 by SONO WEST LLC, an Illinois limited liability company ("Declarant").

RECITALS:

- A. - B. The Declaration reserved to Declarant the right to annex and add to the Condominium Parcel, and thereby add to the condominium created by the Declaration, all or any portion of the Add-On Parcel (as defined in the Declaration) for the purpose of constructing additional Units.
- C. Declarant now desires to so annex and add to the Condominium Parcel and submit to the provisions of the Act and the Original Declaration a certain portion of the

Add-On Property as described in <u>Seventeenth Amended Exhibit B-1</u> attached hereto and incorporated herein by this reference as part of Parcel 23D (Unit 2305), Parcel C26C (Unit 2601) and Parcel C27E (Unit 2701) (said Units being, the "Seventeenth Add-On Parcel").

NOW, THEREFORE, Declarant does hereby amend the Original Declaration (the Original Declaration as amended hereby being, the "**Declaration**"), as follows:

- 1. **Recitals**. The foregoing recitals are incorporated in this Seventeenth Amendment as though fully contained herein.
- 2. Additional Property. The Seventeenth Add-On Parcel is hereby annexed to the Concorninium Parcel, and is hereby submitted to the provisions of the Act as part of Condominum in accordance with, and shall be deemed governed by, the terms and provisions of the Declaration. Accordingly, from and after the date hereof all references in the Declaration to the Condominium Parcel shall include the Seventeenth Add-On Parcel.
 - 3. Amendments. The Original Declaration is further amended as follows:
 - A. Legal Description of Condominium Parcel. Sixteenth Amended Exhibit B-1 of the Declaration (Legal Description of the Condominium Parcel) is hereby amended by deleting said Sixteenth Amended Exhibit B-1 and substituting Seventeenth Amended Exhibit B-1 attached hereto in lieu thereof.
 - B. Additional Condominium Area. Sixteer.ch Amended Exhibit B-2 of the Declaration (Additional Condominium Area) is hereby amended by deleting said Sixteenth Amended Exhibit B-2 and substituting Seventeenth Amended Exhibit B-2 attached hereto in lieu thereof.
 - C. Plat of Survey. Exhibit C of the Declaration (Plat of Survey) is hereby amended by replacing pages 2A, 3 and 7 (Parking), 24, 27 and 28 of said Plat of Survey with pages amended 2A, 3 and 7 (Parking), 24, 27 and 28 attached herete and made a part hereof ("Amended Plat Pages"), to include the Units included in the Seventeenth Add-On Parcel attached hereto. Exhibit C will hereafter consist of Seventeenth Amended Exhibit C attached hereto to include the Amended Plat Pages
 - D. Percentage of Interest. Sixteenth Amended Exhibit D of the Declaration (Percentage of Interest in the Common Elements), as further amended as aforesaid, is hereby further amended by deleting said Sixteenth Amended Exhibit D and substituting Seventeenth Amended Exhibit D attached hereto in lieu thereof. The percentage of ownership in the common elements appurtenant to each Unit is hereby amended to be the percentages set forth in Seventeenth Amended Exhibit D attached hereto.

- E. Number of Units. The maximum number of Units to be submitted as part of the Condominium Property is two hundred (200), including the Parking Unit. Ten (10) Units were submitted with the Original Declaration, twenty-four (24) Units were submitted with the First Amendment, nine (9) Units were submitted with the Second Amendment, thirteen (13) Units were submitted with the Third Amendment, one (1) Unit was submitted with the Fourth Amendment, thirteen (13) Units were submitted with the Fifth Amendment, three (3) Units were submitted with the Sixth Amendment, three (3) Units were submitted with the Seventh Amendment, sixteen (16) Units were submitted with the Eighth Amendment, seven (7) Units were submitted with the Ninth Amendment, fifteen (15) Units were submitted with the Tenth Amendment, twenty (20) Units were submitted with the Eleventh Amendment, twenty-one (21) Units were submitted vitin the Twelfth Amendment, one (1) Unit was submitted with the Thirteenth Amendment, four (4) Units were submitted with the Fourteenth Amendment (2 of which 2303 and 2805, were deemed to have been submitted with the aforesaid Twelfth A number, as they were inadvertently omitted from that Twelfth Amendment), eight (8) Units were submitted with the Fifteenth Amendment, six (6) Units were succentred with the Sixteenth Amendment, three (3) Units are to be submitted with this Seventeenth Amendment, and an additional twenty-three (23) Units, including the Farking Unit, remain to be submitted as part of the remaining Add-On Parcel.
- F. Parking. Handicap Parking Spaces P-2, P-3, P-4, P-5 and P-6 are hereby replaced with Parking Spaces P-2, Y-2A, P-3, P-3A, P-4, P-4A, P-5, P-5A, P-6 and P-6A, as depicted on Revised Plat Page 3. Parking Spaces P-229 through P-238 inclusive are hereby replaced with handleap Parking Spaces P-229, P-231, P-233, P-235 and P-237, as depicted on Revised Plat Page 7.
- G. Reserved LCE Spaces. Parking Spaces P-2, P-2/, P-3, P-3A, P-4, P-4A, P-5, P-5A, P-6 and P-6A shall not be Reserved LCE Parking Spaces, and shall not be reserved for the exclusive use of the Parking Unit Owner and its invitees to the exclusion of Residential Units. Parking Spaces P-19 through P-77 were previously deleted from Reserved LCE Spaces in the aforesaid Six h and Twelfth Amendments. Accordingly, Parking Spaces P-7 through P-18 shall be the only remaining Reserved LCE Parking Spaces, reserved for the exclusive use of the Parking Unit Owner and its invitees to the exclusion of Residential Units.

H. By-Laws.

- (A) The reference in Section 2.1 of the By-Laws to "8 East Randolph Street" is hereby amended to refer to "860 West Blackhawk Street."
- (B) At the option of the initial Board, the first annual meeting of the Unit Owners may be held within 60 days after the initial meeting of the Unit Owners (turnover meeting), and thereafter the annual meetings of the Unit Owners shall be held on the second Wednesday of September of each

succeeding year after the first such annual meeting. If the initial Board elects not to hold such first annual meeting, then the initial meeting shall also be deemed to be the first annual meeting of Unit Owners and the initial Board shall serve in such capacity until the second annual meeting of Unit Owners.

- (C) Provided proper notices are given, the voting for the initial Board may be held by an electronic voting process initiated by the Unit Owners, and coordinated with the Developer, prior to the initial turnover meeting, and any action so taken shall be deemed ratified and confirmed at the initial turnover meeting of the Unit Owners.
- 4. <u>Common Elements</u>. The additional Common Elements annexed to the Condomin unit by this instrument are hereby granted and conveyed to the grantees of all Units, including the grantees of Units heretofore conveyed, all as set forth in the Declaration.
- 5. Inconsistencies. Except as expressly set forth herein, the Original Declaration shall remain in full force and effect in accordance with its terms. Any inconsistencies between the Original Declaration and this Seventeenth Amendment shall be resolved in favor of the provisions contained in this Seventeenth Amendment.


