Covenant Regarding Driveway And Apron Responsibility

The undersigned certify that we are the owner(s) (Owner) of real property (Subject Property) located in the Village of Hoffman Estates, County of Cook, State of Illinois, that is legal described as follows:

LOT 14 IN BLOCK 32 IN HOFFMAN ESTATES II, BEING A SUBDIVISION OF THAT PART LYING SOUTH OF HIGGINS ROAD (AS THAT ROAD EXISTED ON AUGUST 30, 1926) OF THE NORTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 14, TOWNSHIP 41 NORTH, RANGE 10, EAST OF THE THIRD PRINCIPAL MERIDIAN AND OF THE NORTHEAST QUARTER OF SECTION 15, TOWNSHIP 41 NORTH, RANGE 10, EAST OF THE THIRD PRINCIPAL MERIDIAN AND THE NORTH HALF OF THE SOUTHEAST QUARTER OF SECTION 15, TOWNSHIP 41 NORTH, RANGE 10, EAST OF THE THIRD PRINCIPAL MERIDIAN ACCORDING TO THE PLAT THEREOF RECORDED MARCH 8, 1956 AS DOCUMENT 16315708, IN COOK COUNTY, ILLINOIS.

Section 1: Declaration of Covenant. Now, therefore, the Owner declares that the Subject Property and all portions of it are and shall be held, transferred, sold, conveyed, used and occupied subject to the covenants hereinafter set forth, which covenants are the purpose of protecting the value and desirability of the Subject Property in the Village of Hoffman Estates.

Section 2: Replace and Hold Harmless. In consideration of the issuance by the Village of Hoffman Estates of a permit for the construction of a driveway or driveway apron of brick pavers upon the Subject Property or a driveway or driveway apron of brick pavers upon any easement of the above described property or upon the adjacent public right of way dedicated to the Village of Hoffman Estates, the Owner does hereby covenant and agree to repair and replace all or any portion of the said driveway or driveway apron upon or adjacent to the Subject Property that is removed or distributed for the purpose of

utility work, snow removal, street reconstruction, street repair or sidewalk construction or sidewalk repair at Owner's sole cost. The Owner further agrees to hold harmless and indemnify the Village of Hoffman Estates from any damage to the public easement or adjacent public right-of-way by construction or use of the driveway or driveway apron.

Section 3: Amendment. This Covenant may be modified, amended, or annulled only upon the express, prior written approval of the Village of Hoffman Estates, by resolution duly adopted.

Section 4: Covenants Running with the Land. The covenants and restrictions hereby imposed shall run with the land and shall be binding upon and inure to the benefit of the Owner and its successors, assigns, agents, licenses, invitees and representatives, including, without limitation, all subsequent owners of the Subject Property, or any portion thereof, and all persons claiming under them.

Section 5: Recordation. This Covenant shall be recorded with the Recorder of Deeds of Cook County, Illinois, and all contracts and deeds of conveyance relating to the Subject Property, or any part thereof, shall be subject to the provisions of this Covenant. The owner(s) agree to pay the fee for the preparation and recordation of this Covenant.

Section 6: Term. The restrictions hereby imposed shall be enforceable for a term of 100 years from the date this Covenant is recorded, after which time such Covenant shall be automatically extended for successive periods of 10 years unless an instrument amending this Covenant shall be recorded and provide for some other duration.

Section 7: Severability. Invalidation of any one of these covenants and restrictions by a judgment or court order shall in no way affect any other provisions, which shall remain in full force and effect.
