- 3. On or about May 25, 2010, Claimant completed all of the Work under the terms of and in accordance with the Contract, in that Claimant supplied all labor and materials necessary for performance of its duties under the Contract for the improvements to the Property. The Work consisted of the following: Removed and disposed of existing gutters and downspouts and installation of gutters and downspouts.
