- 4. Amendment of Exhibit D. To re lect the addition of the Added Dwelling Units, the list of the Undivided Interests of the Dwelling Units as shown in Exhibit D to the Declaration is hereby amended to be as set forth in the Sixth Ar rended and Restated Exhibit D, which is attached hereto.
- 5. Covenants to Run With Land. The covenants, conditions, restrictions and easements contained in the Declaration, as amended by this Supplement I Declaration shall run with and bind the Condominium Property, including the Added Property and Added Dwelling Units.
