1. - 2. (a) On or about 6/11/2008, the Executor of the Estate, as Seller, entered into a written contract to sell said real estate to Ion Goldman, as Purchaser.
- 2. (b) After extensions of time to Close given by the Estate to Jon Goldman (and to his wife, Erica Goldman) in which to Close on the purchase, a default was declared against Purchasers, for their inability to furnish the balance of the purchase price, and the Purchasers admitted the default.
- 3. (a) On 11/7/2008, Purchasers recorded, as Document #0831234065, the contract, in the Office of Recorder of Deeds of Cook County, 25 Notice of the pendency of the Contract, notwithstanding the fact that they were then in default.

- 3. (c) The Broker in that transaction, HomeSite Realty, Inc. Claimed the Earnest Money, then held by said Broker, and Claims were filed, in the Estate proceedings, by the Etoker and by the Goldmans.
- 3. (d) All Claims to the other matters were amicably settled and adjusted by and among the Estate, the Goldmans, and the Broker, and same were dismissed by written agreement and by Order of Court entered on 2/4/10; a copy of said Order is attached hereto.
- 3. (e) After full settlement, and payments, and entry of said Court Order, Goldmans have not asserted any claim or rights under said recorded Document.
 - 4. Wherefore, Affiant asserts that Document #0831234065 is of no legal effect and is a nullity.
- 5. This Affidavit is made to induce Chicago Title Insurance Company to waive any objections in its future title commitments or Policies which may appears a result of the recording of said Document #0831234065.
