ESTOPPEL AFFIDAVIT

THIS AFFIDAVIT, made this 29 day of JUNE, 2010, by DANIEL GOLDEN, Independent Executor of the Estate of Minnette Golden, deceased, hereinafter referred to as Grantor,

WITNESSETH:

That Minnette Golden did on the 2nd day of December, 2008, execute and deliver a certain Promissory Note in the principal sum of Two Hundred Ten Thousand Dollars (\$210,000.00) and secured by a Mortgage dated December 2, 2008, and duly recorded in the Recorder's Office of Cook County, State of Illinois, as Document No. 0901617001 conveying the real estate located at 555 Manistee Avenue, Calumet City, Cook County, Illinois, and legally described as follows:

LEGAL DESCRIPTION:

Lot 30 in Block 8 in Ford Calumet Center, a Subdivision of West 1376.16 feet of the North ½ of the South West ¼ of Section 7, Township 36 North, Range 15 East of the Third Principal Meridian, in Cook County, Illinois.

That the Estate of Minnette Golden, deceased has defaulted in the payments due on said Note, plus interest and necessary advancements due and outstanding and is unable to meet the obligations of said Note and Mortgage according to the terms thereof.


That the said Grantor has made, executed and delivered that certain Deed to **FEDERAL NATIONAL MORTGAGE ASSOCIATION** dated the 29 day of JUNE, 20 10, conveying the above described property. The said Grantor hereby acknowledges, agrees and certifies that the aforesaid deed was an absolute conveyance of the Grantor's right, title and interest in and to said real estate, together with all buildings thereon and appurtenances thereunto belonging and appertaining, and with release of all dower and homestead rights in and to said real estate, and also conveys, transfers and assigns the Grantor's rights of possession, rentals and equity of redemption in and to said premises. The value of said real estate is not in excess of the amount of said indebtedness outstanding and in consideration of the premises hereof and in consideration of such conveyance, the Grantor has received a full and complete release of personal liability on said Note together with the cancellation of record by said Grantee of the Note secured by said Mortgage.

Said Deed was given voluntarily by the Grantor to the Grantee, in good faith on the part of Grantor and Grantee, without any fraud, misrepresentation, duress, or undue influence whatsoever, or any misunderstanding on the part of the Grantor or Grantee and was not given as a preference against any other creditors of said Grantors. Said Deed of conveyance shall not effect a merger of the fee title to the premises with Grantee's Mortgage lien and shall not restrict the right of the Grantee to institute foreclosure proceedings if the Grantee desires, but the conveyance by said Deed shall be and is hereby intended and understood to be an absolute conveyance and an unconditional sale, with full extinguishment of Grantor's equity of redemption, and with full release of all Grantor's right, title and interest of every character in and to said property. Grantor hereby assigns to Grantee the hazard insurance policy now in effect on said property and further assigns to Grantee the right to receive payment of any claim payable under the terms of said policy including any premium refund now or hereafter payable.


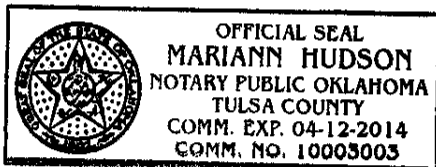
