- 2.) Alcamar Construction Co. removed all plaster of walls of the stair; and primer floor of the second floor; installed new drywall on the walls of the stairs; plaster and painted all walls of the stairs; installed new cabinets in the kitchen: the faucet, sink, and counter top; installed new toilet, sink, and medicine cabinet in bathroom; installed two vinyl windows on the back porch; installed and painted new baseboards in all of the apartment; installed new furnace and grill vents; installed new roof on the front porch; installed new carpet in three bedrooms and on the stairs; sanded the wood floor in the living room and dining room; installed all light fixtures and fan in the apartment; and
