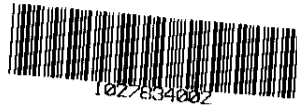

## AMENDMENT TO DEED

Grantor Eleftherios Shaltapour, as evidenced by his signature below, submits this Amendment to Deed solely for the purpose of reforming an incorrect legal description on the existing Deed of record with the Cook County Recorder of Deeds. In particular, document number 0534045124, recorded with the Cook County Recorder of Deeds on December 6, 2005 should be amended so that the legal description includes both Lot 1289 and Lot 1290 as being transferred from Grantor to Grantee Radmila Grocic, as Trustee and not personally under the provisions of a Trust Agreement dated the 9<sup>th</sup> day of June, 2005, known as Trust 2804 Rascher Residential Land Trust, State of Illinois. The correct legal description should now read:

LOT 1289 (EXCEPT THE NORTH 8 FEET THEREOF) AND LOT 1290 IN WILLIAM H. BRITTIGAN'S BUDLONG WOODS GOLF CLUB ADDITION NUMBER 4, BEING A SUBDIVISION OF THAT PART OF THE NORTH HALF OF THE NORTHWEST QUARTER OF SECTION 12, TOWNSHIP 40 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN LINE EAST OF THE NORTHEASTERLY RIGHT OF WAY OF THE SANITARY DISTRICT OF CHICAGO (EXCEPT THE NORTH 33 FEET TAKEN FOR BRIN MAWR AVENUE) IN COOK COUNTY, ILLINOIS.

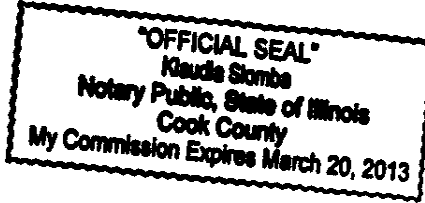
