#### ORDER

("3D") and Motion For Summary Judgment Against Developers Indemnity And Surety Company ("Developers"), all parties having notice and the court being fully advised:

#### IT IS ORDERED:

- (1) With respect to Developers' Second Amended Counterclaim, for the reasons stated on the record, summary judgment with respect to Count I is granted in favor of F.B. Moran, Inc., and IRB Construction Partners. The Motion For Summary Judgment is denied as to: University of Chicago for Count I, and University of Chicago and IRB Construction Partners as to Count II. This denial is without projudice as to issues of whether Columbia Pipe & Supply Co., Inc. had an agency relationship with Advantage Lien Protection, LLC; and
- (2) With respect to 3D's Amended Complaint, for the reasons stand on the record, summary judgment is granted in favor of Movants and against 3D as to Counts II and III.
