WHEREAS, on January 28, 2010 Bank of America, N.A. a national banking association as successor to LaSalle Bank national Association and acting as agent for itself and others in respect of the Senior Loan hereinafter defined, Plaintiff filed its Verified Complaint To Foreclose Mortgage And For Other Relief against Silver Tower Chicago, LLC, et al, which was filed in the Circuit Court of Cook County Illinois, County Department, Chancery Division as Case No. 10 CH 03924 ("Litigation") pertaining to the Construction Loan Agreement dated June 29, 2007, made by LaSalle Bank National Association and recorded July 10, 2007, as document number 0719140161, Assignment of Agreements dated June 30, 2009, as document number 0919803069 (as amended by the First Modification and the Second Modification, each as defined as the "Senior Loan Agreement") between Silver Tower Chicago, LLC (the Borrower") and with LaSalle Bank National Association and other financial institutions that of and may from time to time become parties to the Senior loan Agreement (collectively the "Banks") , whereby the Banks loaned to Borrower the sum of \$60,000,000 .00 (the "Senior Loan") in connection with the acquisition and developed of certain real premises located at 239 W. Ohio Street, Cook County, Chicago, Illinois (the "Mortgaged Premises") which Senior Loan was evidenced by (i) that certain Promissory dated as of June 29, 2007, executed by the Borrower to the order of the Banks in the original principal amount of \$34,000,000.00; (ii) that certain Promissory Note executed June 29, 2007, by Borrower to the order of M.B. Financial Bank, N.A. in the original principal amount of \$21,000,000.00; and (iii) that certain Promissory Note dated as of June 29, 2007, executed by Borrower to the order of the Peoples Bank SB in the original principal amount of \$5,000,000.00 (collectively, as amended by the First Modification and the Second Modification, the "Senior Notes") Mortgage dated June 29, 2007, and recorded July 10, 2007, as document number 0719140163, made by Silver Tower Chicago LLC, an Illinois limited liability company, to LaSalle Bank National Association, to secure an indebtedness of \$7,200,000.00; Assignment of Agreements Affecting Real Estate dated June 29, 2009, and recorded July 17, 2009, as document number 0919829036; Assignment of Leases and Rents dated June 29, 2007, and recorded July 10, 2007, as document number 0719140164, made by Silver Tower Chicago LLC, an Illinois limited liability company to LaSalle Bank National Association; Subordination of Mortgage and Intercreditor Agreement between Silver Tower Chicago, LLC, an Illinois limited liability company, LaSalle Bank National Association and Connaught Mezzanine Fund

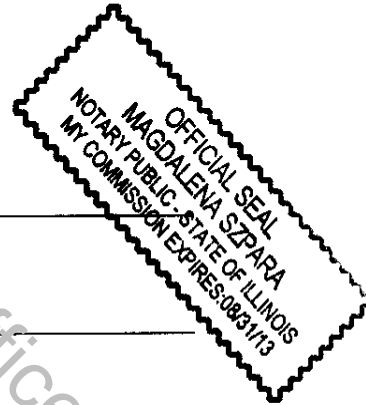
