THIS CAUSE coming to be heard pursuant to the Stipulation and Settlement Agreement and Agreed Order of Dismissal by and between Plaintiff, Allied Building Products Corporation ("Allied") and Defendants, TQ, Inc. ("TQ") and Richard Booker ("Booker") and the agreement thereof for the entry of this Consent Judgment in favor of Allied and against TQ and Booker, jointly and severally, with Defendants TQ and Booker, having defaulted in making payments due and owing to Allied pursuant to the Stipulation and Settlement Agreement and Agreed Order of Dismissal; due notice having been given and the Court being fully advised in the premises;

IT IS HEREBY ORDERED:

1. Judgment by Consent shall be and is hereby entered in favor of Allied Building Products Corporation and against Defendants TQ, Inc. and Richard Booker, jointly and severally, in the principal amount of \$57,766.68, plus interest at a rate of 18% per annum, \$28.49 per diem, accrued on the principal amount that has gone unpaid from and after the Effective Date of the Stipulation and Settlement Agreement and Agreed Order of Dismissal of July 9, 2009 to today's date totaling \$ 2,364.67, plus all reasonable attorneys' fees and costs incurred in initiating and litigating the underlying lawsuit and this Consent Judgment Order, totaling


