

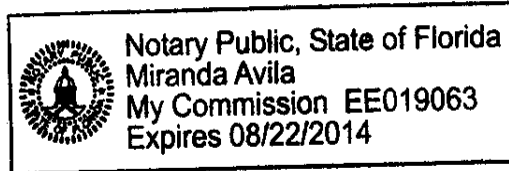

Parcel I:
