SUBCONTRACTOR'S CLAIM FOR LIEN

The claimant, BARGE TERMINAL TRUCKING, INC. ("Claimant"), of 115 Kirkland Circle, Oswego, Illinois 60543, hereby files its claim for lien against **BLAKE LORD ASSOCIATES, INC.** ("Contractor"), of 237 W. Palatine Road, Schaumburg, County of Cook, State of Illinois 60067 and the attached Exhibit "A" for Owners ("Owner"), of the City of Wheeling, County of Cook, State of Illinois and any persons claiming an interest in the premises herein, and states:

1. That on June 29, 2010 and all times thereafter, the Owner owned the following land legally described on Exhibit "B" in the County of Cook, State of Illinois, commonly known as **200 Deborah Lane, Wheeling, Illinois** (PIN # see attached Exhibit "B") and **BLAKE LORD ASSOCIATES, INC.** was the Owner's contractor for the improvement thereof.


2. That on June 29, 2010 the Contractor made an oral subcontract with the Claimant to provide building materials and trucking services for and in the improvement, and that on June 29, 2010, the Claimant completed work to the value of **\$4,543.87**.

In the event an apportionment or allocation of claim for lien is required by law, claimant claims a lien on each condominium unit set forth in Exhibit "A" and all the commercial units in accordance to the percentage of ownership interest as it relates to each unit.

3. That said Contractor is not entitled to any credits on account thus: leaving due, unpaid, and owing to the Claimant, after allowing all credits, the sum of **\$4,543.87**, for which, with interest, the Claimant claims a lien against the Contractor and the Owner on the land and improvements and on the money or other consideration due or to become due from the Owner under the contract.





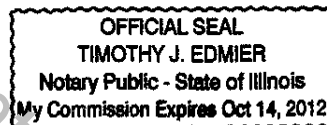
