- (c) Easements, covenants, restrictions, agreements, conditions and building lines of record and party wall rights;

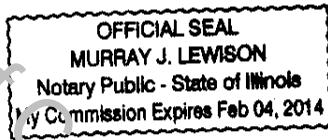
