- B. Mortgagor appoints Lender as attorney in fact to sign Mortgagor's name or pay any amount necessary for performance. 


Property. Any action or inaction occurs that adversely affects the Property or Lender's rights in the Property. 
7. REMEDIES ON DEFAULT. In addition to any other remedy available under the terms of this Security Instrument. 
