MATERIAL SUPPLIER'S MECHANICS LIEN CLAIM

1. Since at least July 27, 2010, and subsequently, Owner has owned fee simple title to the Subject Property, including any and all improvements thereon legally described as follows:

Enterprises Subdivision, being a part of the southwest 1/4 of Section 31, township 41 north, Range 11 east of the third principal meridian, according to the plat thereof, recorded August 1, 1985 as Document No. LR3452187, in Cook County, Illinois

Parcel 2: Easement for ingress and egress of vehicular and pedestran traffic for the benefit of Parcel 1 as created by declaration of easements, covenants and restrictions recorded August 8, 1985 as Document No. LR3453708, in Cook County, Albois

- 2. On or about May 14, 2006, Contractor signed a written application for credit with Claimant pursuant to which Claimant agreed to provide asphalt materials to Contractor on credit terms referenced therein. A true and correct copy of which is attached hereto as Exhibit A.
- 3. On July 27, 2010, Contractor ordered from Claimant and Claimant supplied asphalt material to Contractor for the improvement of and the incorporation of the asphalt material into the Subject Property, pursuant to the terms of its application for credit.

- 4. Claimant complied with all of the terms of the credit application of Contractor by supplying all the asphalt materials requested.
- 5. The last date on which Claimant supplied asphalt materials to Contractor for the Subject Property was July 27, 2010.
- 6. There is due, unpaid and owing to Claimant therefore, after allowing all credits, the sum of \$4,789.54, plus interest, costs and attorneys fees, provided for in the application for credit and Claimant claims a lien against the Subject Property and improvements constructed thereon and against all money or other consideration due or to become due to Contractor.
