The Mortgagor, Nortgagee and certain other parties are entering or have entered into an Indenture, dated as of \_\_\_\_\_\_\_, 2010 (as amended, restated or supplemented from time to time in accordance with its terms, the "Indenture"), pursuant to which affiliates of Mortgagor will from time to time issue notes; and

The buildings, structures, fixtures, additions, enlargements, extensions, modifications, repairs, replacements and improvements now or hereafter erected or located on the Land in which Mortgagor may have an interest pursuant to the Purchase Agreement (collectively, the "**Improvements**");
- (c) <u>Fixtures and Personal Property</u>. All machinery, equipment, fixtures and other property of every kind and nature whatsoever in which Mortgagor may now or hereafter have an interest purguant to the Purchase Agreement (collectively, the "**Personal Property**"), and all proceeds and products of the above;

- (c) sell for cash or upon credit the Property or any part thereof and all estate, claim, demand, right, title and interest of Mortgagor therein and rights of redemption thereof, pursuant to power of sale or otherwise, at one or more sales, as an entirety or in parcels, at such time and place, upon such terms and after such notice thereof as may be required or permitted by law;

#### Article 12 - APPLICABLE LAW

- Section 12.1 GOVERNING LAW. This Security Instrument shall be governed, construed, applied and enforced in accordance with the laws of the state in which the Property is located and applicable laws of the United States of America.
- Section 12.2 PROVISIONS SUBJECT TO APPLICABLE LAW. All rights, powers and remedies provided in this Security Instrument may be exercised only to the extent that the exercise thereof does not violate any applicable provisions of law and are intended to be limited to the extent necessary so that they will not render this Security Instrument invalid, unenforceable or not entitled to be recorded, registered or filed under the provisions of any applicable law. ## Article 13 - Mis CELLANEOUS PROVISIONS

This Security Instrument, and any provisions hereof, may not be modified, amended, waived, extended changed, discharged or terminated orally or by any act or failure to act on the part of Mortgagor or Mortgagee, but only by an agreement in writing signed by the party against whom enforcement of any modification, amendment, waiver, extension, change, discharge or termination is sought.
- Section 13.2 <u>Successors and Assigns</u>. This Security instrument shall be binding upon and inure to the benefit of Mortgagor and Mortgagee and their respective successors and assigns forever.

Upon the occurrence and during the continuance of an Event of Default, Mortgagee shall have the right to insurate a proceeding or proceedings for the total or partial foreclosure of this Security Instrument and any or all of the Additional Security Instruments whether by court action, power of sale or otherwise, under any applicable provision of law, for all of the Debt or the portion of the Debt allocated to the Property in this Security Instrument, and the lien and the security interest created by the Additional Security Instruments shall continue in full force and effect without loss of priority as a lien and security interest securing the payment of that portion of the Debt then due and payable but still outstanding. ### **Article 15 - STATE SPECIFIC PROVISIONS**

- Section 15.1 PRINCIPLES OF CONSTRUCTION. In the event of any inconsistencies between the terms and conditions of this Article 15 and the terms and conditions of this Security Instrument, the terms and conditions of this Article 15 shall control and be binding.
- Section 15.2 The words, "accessions to and substitutions and replacements for," are hereby added after the words "all proceeds and products of" in subsection (d) of Section 1.1 of this Security Instrument entitled "Property Mortgaged."
- Section 15.3 <u>REMEDIES UPON DEFAULT</u>. (a) In Subsection 7.1(d) of this Security Instrument entitled "Remedies", the following parenthetical shall be added following the words "shall automatically be revoked":

"(the previsions for the appointment of a receiver and assignment of rents being an express condition upon which the Debt secured hereby is made)"

- Section 15.4 None of the Property falls within the definition of "real property" set forth in the Illinois Responsible Property Transfer Act of 1988, 765 ILCS §90-1 et seq. §90-3(e), as amended.
- Section 15.5 <u>USE OF PROCEEDS</u>. Mortgagor hereby represents and agrees that the proceeds of the advances secured by this Security Instrument will be used for the purposes specified in the Illinois Interest Act, 815 ILCS §205/4(1), and the Debt secured hereby constitutes a business loan which comes within the purview of said Section 205/4(c).

## Section 15.6 ILLINOIS MORTGAGE FORECLOSURE LAW.

- (a) In the event any provision in this Security Instrument shall be inconsistent with any provision of the Illinois Mortgage Foreclosure Law (735 ILCS Sections 5/15-1101 et. seq., Illinois Compiled Statutes) (the "Foreclosure Act"), the provisions of the Foreclosure Act shall take precedence over the provisions of this Security Instrument, but shall not invalidate or render unenforceable any other provision of this Security Instrument that can be construct in a manner consistent with the Foreclosure Act.
