(the "Lender") of the same date and covering the Property described in the Security Instrument and located at: 807 West Lill Pre Init 104, Chicago, IL 60614.

The Property includes a unit in, together with an undivided interest in the common elements of, a condominium project know it as: Lil Street Condominium

(the "Condominium Project"). If the owners association or other entity which acts for the Condominium Project (the "Owners Association") holds title to property for the benefit or use of its members or shareholders, the Property also includes Borrower's interest in the Owners Association and the uses, proceeds and benefits of Borrower's interest.
