MEMORANDUM OF LEASE

THIS MEMORANDUM OF AGREEMENT (this "Memorandum") is a memorandum dated as of this 22nd day of November, 2010 by and between NORTHBROOK CONGREGATION EZRA HAB DNIM ("Ezra") having an address at 2095 Landwehr Road, Northbrook, Illinois 60062, and DAYCHEI NOAM GLENBROOK ("DNG") having an address at 2095 Landwehr Road, Northbrook, Illinois 60062.

WHEREAS, this Memorandum is executed in connection with that certain Agreement dated as of March 17, 2010 by and between Ezra and DNG (the "Agreement").

WHEREAS, Ezra leases to DNG, and DNG leases from Ezra certain premises in the building located at 2095 Landwehr Road in the County of Cook, Village of Northbrook, State of Illinois, described in Exhibit "A" attached hereto.

NOW THEREFORE, in consideration of the mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is agreed as follows:


