SUBORDINATION OF LIEN

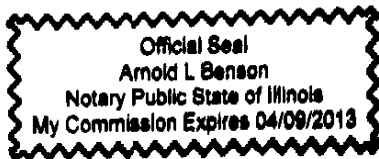
