EIGHTH AMENDMENT TO THE DECLARATION OF CONDOMINIUM OF SUPERIOR 110 CONDOMINIUM

exercise the right and power reserved in Section 14 of the Declaration to add and submit certain real estate to the provisions of the Declaration and the Act.

NOW THEREFORE, the Declarant does hereby supplement and amend the Declaration as follows:

- 1. <u>Defined Terms</u>. All terms used herein if not otherwise defined herein shall have the meanings set forth in the Declaration.
- 2. Appendix A. Appendix A is deleted in its entirety and amended to read as set forth on Exhibit A to this Amendment. Such amended Appendix A provides for the addition of all of the remaining Additional Parcel.
- Parcel which is described as set forth on Exhibit B to this Amendment is hereby made subject to the Declaration as Additional Parcel and is submitted to the provisions of the Act. Appendix A to the Declaration is hereby amended (as set forth on Exhibit A attached to this Amendment) to include the Additional Parcel. All of the Additional Parcel has now been added to the Declaration.
- 4. Amendment of Appendix B. Appendix B to the Declaration is hereby amended on Pages 2, 3, 3A, 5, 6, 7, 8, 20, 21, 22, 27, 24, 25, 27 and 28, to read as set forth on the attached Exhibit C to this Amendment and such plat reflects the Additional Parcel which is added to the Condominium pursuant hereto, the designation of the Storage Lockers and their numbers and correction of a scrivener's error on Exhibit C of the Declaration. Appendix B as hereby amended and supplemented identifies each Added Uni in the Additional Parcel and assigns to it its unit number.
- 5. <u>Amendment to Appendix C</u>. To reflect the addition of the Added Units, the list of the percentage of ownership interest in the common elements as shown on Appendix C to the Declaration is hereby amended to be as set forth in the Eighth Amended and Restated Appendix C which is attached hereto as <u>Exhibit D</u>.
- 6. Amendment of Appendix E. Appendix E to the Declaration is pereby amended to delete the following units from the Additional Parcel: Units 701, 703, 2001, 2003, 2101, 2103, 2200, 2301, 2303, 2401, 2403, 2501, 2503, P-42, P-43, P-44, P-45, P-46, P-47, P-51, P-52, P-57, P-58, P-61, P-62, P-66, P-67, P-69, P-82, P-83 and P-85. There are no longer any Units on Appendix E to the Declaration.
- 7. <u>Covenants to Run with the Land</u>. The covenants, conditions, restrictions and easements contained in the Declaration as amended by this Amendment shall run with and bind the Condominium including the Additional Property and the Added Units.
- 8. <u>No Further Amendment</u>. Except as expressly set forth herein, the Declaration shall remain in full force and effect in accordance with its terms.
