5. Property Insurance. Borrower shall keep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards included within the term "extended coverage," and any other hazards including, but not limited to, earthquakes and floods, for which Lender requires insurance. This insurance shall be maintained in the amounts (including deductible levels) and for the periods that Lender requires. the excess, if any, paid to Borrower. Such insurance proceeds shall be applied in the order provided for in Section 2.

If Borrower abandons the Property. Lender may file, negotiate and settle any available insurance claim and related matters. If Borrower does not respond within 30 days to a notice from Lender that the insurance carrier has offered to settle a claim, then Lender may negotiate and settle the claim. The 30-day period will begin when the notice is given. - 7. Preservation, Maintenance and Protection of the Property; Inspections. (B) The Index

Beginning with the first Change Date, my adjustable Interest rate will be based on an Index. The "Index" is the average of interbank offered rates for one-year U.S. dollar enominated deposits in the London market ("UBOR"), as published in <u>The Wall Street Journal</u>. The most recent index figure available as of the date 45 days before each Change Date is called the "Current Index."
