SUBORDINATION OF LIEN

THIS SUBORDINATION OF LIEN (this "Agreement") is dated this 17th day of November, 2010 and is executed by THE NORTHERN TRUST COMPANY, an Illinois banking corporation ("Subordinating Lender") for the benefit of FIRST ILLINOIS MORTGAGE, INC. DBA FIRST ILLINOIS MORTGAGE SERVICES ("Senior Lender").

WITNESSETH

WHEREAS, Gregory F. Werd, Jr. And Margaret Shortridge Werd, Husband And Wife, As Tenants By The Entirety, ("Property Owner") executed a Mortgage or Deed of Trust (hereinafter the "Junior Mortgage") in favor of Subordinating Lender dated 6/13/2008 and which was recorded in the Office of the Recorder of Cook County, Illinois, on July 17, 2008 as Document Number 0819957055 encumbering the real estate and all buildings, structures, fixtures and improvements thereon (the "Premises") which has the street address of 319 Essex Road, Kenilworth, IL 60043 and is legally described on Exhibit A attached hereto and made a part hereof; and

WHEREAS, the Junior Mortgage was made to secure a promissory note (the "Note") in the face principal amount of \$500,000.00 United States dollars which is payable as therein provided; and



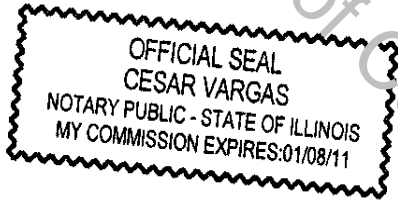
