ORDER

This matter proceeded to bench trial December 1, 2009. The Court, having heard and considered the testimony, exhibits, arguments and the parties' trial memorandums, rules as follows: **IT IS HEREBY ORDERED:**

Judgment is entered in favor of the Plaintiff, Danita Bergrud, only, ("Plaintiff") and against the Defendants, Baltic Man, Inc., an Illinois corporation, and Kestutis Sopa, individually, (collectively "the Defendants") in the amount of \$6,594.01, plus costs for the filing and service of the lawsuit.

Judgment is entered in favor of the Defendants as to the plaintiff, Kevin Bergrud.

The Court makes the following findings: the Defendants (Kestutis Sopa, individually, and Baltic Man, Inc.) are liable to the Plaintiff for breach of contract and for violation of the Illinois Home Repair and Remodeling Act. The judgment amount of \$6,594.01 is comprised of the amounts of \$5,794.01, representing Plaintiff's costs to correct the defective work of the Defendants, and \$800 in attorney's fees awarded pursuant to the Home Repair and Remodeling Act.
