GENERAL CONTRACTOR'S MECHANIC'S LIEN— NOTICE AND CLAIM

The undersigned Claimant, M&M Roofing, Inc., of 3488 Eagle Nest Drive, Crete, IL, County of Will (the "Claimant"), hereby claims a mechanics lien pursuant to the Mechanics Lien Act of the State of Illinois against Kathryn DePratto regarding the property commonly known as 19908 Lakewood Ave, Lynwood IL 60411, County of Cook (the "Owner(s)") and states as follows:

1. Owner(s) now holds title to that certain real property in the County of Cook, State of Illinois (the "Property"), to wit:

LEGAL DESCRIPTION

The Property is commonly known as 19908 Lakewood Ave, Lynwood IL 60411, County of Cook. Permanent Real Estate Index Number PIN #33-07-308-014-0000.
Subdivision being acreage, of Section 07, Township 35 North, Range 15 East of the Third Principal Meridian, in Cook County, Illinois.

2. On or about September 8, 2010 Claimant and Owner(s) entered into that certain agreement (the "Contract") for the performance of certain work and/or the delivery of certain materials by Claimant (the "Work") for the sum of Four Thousand, Seven Hundred, Twenty Dollars (\$4,720.00) (the "Contract Sum").
3. On or about September 29, 2010, Claimant completed all of the Work under the terms of and in accordance with the Contract, in that Claimant supplied all labor and materials necessary for performance of its duties under the Contract for the improvements to the Property. The Work consisted of the following: Tear off and installation of Owens Corning shingles, installation of a power vent, electrical disconnection and reconnection, and plywood replacement.

All of the labor and materials furnished and delivered by Claimant were furnished to and used in connection with the improvement of the Property, and the last of such labor and materials was furnished, delivered and performed, and the work contemplated under the Contract completed, on or about September 29, 2010.
- 5. There is now justly due and owing the Claimant after allowing to the Owner(s) all credits, deductions and offsets, the sum of One Thousand, Seven Hundred Twenty Dollars (\$1,720.00) plus interest at the rate specified in the Illinois Mechanics Lien Act.
- 6. Claimant now claims a lien on the above-described Property, and on all of the improvements therein for of One Thousand, Seven Hundred Twenty Dollars (\$1,720.00) plus interest at the rate specified in the Illinois Mechanics Lien Act, as well as court costs and attorney fees.
