A RESOLUTION ABROGATING A PORTION OF THE BLANKET EASEMENT AREA AND GRANTING IT AS A NON-EASEMENT AREA ON LOT 6 WITHIN THE PRAIRIE CROSSING SUBDIVISION

WHEREAS, the final subdivision plat for Prairie Crossing was recorded on August 17, 2005 with the County Recorder's office;

WHEREAS, the plat contained blanket easement provisions outside of the Non-Easement Area (NEA) building envelopes for public utilities serving the subdivision; and

WHEREAS, a particular building encroaches outside the Non-Easement Areas as platted and the property owner desires to expand the building envelope area (NEA) at this location; and

WHEREAS, there are no imparts on the public utility systems or storm water management facilities; and

WHEREAS, the area desired for the expanded building envelope is currently a blanket easement area with easement rights that must be legally abrogated; and

WHEREAS, the Village of Wheeling, Commonweaith Edison Company, Nicor Gas Company, AT&T Illinois, and Comcast Cable Communication Company find no objections to abrogating their rights in the Blanket Easement which becomes part of the Non-easement Area #6 as shown on Exhibit A; and

WHEREAS, it is proper and legally necessary to correct these deficiencies and encroachments by means of incorporating portions of the easement areas with a plat of abrogation within the subdivision and recording the document with the Councy Recorder's Office; and

WHEREAS, a Plat of Abrogation has been submitted releasing and abrogating utility rights within a portion of an existing Blanket Easement located within Lot 6 in the Prairie Crossing Subdivision, Wheeling, Illinois, in the County of Cook, legally described as follows:

Lot 6 in Prairie Crossing subdivision, being a resubdivision of part of lot 2 in G. Hechinger's farm, being a subdivision in Sections 1, 2, and 3, Township 42 North, Range 11 East, and part of lot 2 in the subdivision of Section 2, Township 42 North, Range 11 East and parts of Section 11 and 13, Township 42 North, Range 11 East of the Third Principal Meridian, according to the plat thereof recorded on August 17, 2005, as Document No. 0522939034, in Cook County, Illinois. P.I.N. 03-02-200-107.

WHEREAS, the President and Board of Trustees find it in the best interest of all parties to cause these aforementioned areas of the Blanket Easement to be abrogated by the Village.


