
## SUBORDINATION AGREEMENT



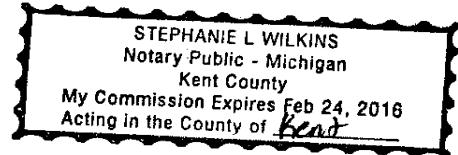
