LOAN MODIFICATION AGREEMENT

A00199458

This Loan Modification Agreem en. ("Agreement"), made this 19th day of November, 2010 between Mario E. Perez and Candida A. Frer 27. ("Borrower") and Central Federal Savings and Loan Association ("Lender"), amends and supplements (1) the Mortgage dated May 5, 2006 and recorded with the Cook County Recorder of Deer's as document 0614405054, and (2) the Note bearing the same date as, and secured by, the Mortgage, which covers the real property described and set forth as follows:

Lot 25 in Block 11 in Arthur T. McIntosh 26th Street Addition, heing a Subdivision of the West 50 Acres (except that part thereof conveyed to the Chicago, Madiron and Northern Railroad Company and except the South 30 Feet thereof) of the South 60 Acres to the North West ¼ of Section 25, Township 39 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois.


Which has the common address of: 2725 S. Park Ave., North Riverside IL 60546 (t'ie "Property").

It is the express intent of the Borrower and Lender to modify the terms and provisions set forth in the Mortgage and Note as follows:

Reduction of interest rate and monthly installments of principal and interest payment as specified in the Note.

In consideration of the mutual promises and agreements exchanged, the parties hereto agree as follows (notwithstanding anything to the contrary contained in the Mortgage or Note):

- 1. As of November 19, 2010, the amount payable under the Note and the Mortgage (the "Unpaid Principal Balance") is \$238,160.70, consisting of the unpaid amount(s) loaned to Borrower by Lender plus any interest and other amounts capitalized.
- 2. Borrower promises to pay the Unpaid Principal Balance, plus interest and all costs, to the order of the Lender. Interest will be charged on the Unpaid Principal Balance at the annual rate of <u>5.000%</u> beginning <u>December 1, 2010</u> Borrower promises to pay the modified monthly payment of principal and interest of <u>\$1,378.57</u> commencing on

<u>January 1, 2011</u> and shall continue the monthly payments thereafter on the same day of each succeeding month until principal and interest are paid in full. If on <u>June 1, 2036</u> (the "Maturity Date"), Borrower still owes amounts under the Note and Mortgage, as modified by this Agreement, the Borrower will pay those amounts in full on the Maturity Date. The Borrower will make such payments at 5953 West Cermak Road, Cicero, Illinois 60804 or at such other place as the Lender may require.

- If all or any part of the Property or any interest in the Property is sold or transferred (or if Borrower is not a natural person and a beneficial interest in Borrower is sold or transferred) without Lender's prior written consent, Lender may require immediate payment in full of all sums secured by the Mortgage.
- 4 Borrower also will comply with all other covenants, agreements, and requirements of the Note and Mortgage, including without limitation, Borrower's covenants and agreements to make all payments of taxes, insurance premiums, assessments, escrive tems, impounds, and all other payments that Borrower is obligated to make under the Mortgage.
- 5. Borrower understands and agrees that:
 - (a) All the rights and remedies, stipulations, and conditions contained in the Mortgage relating to default in the making of payments under the Mortgage's hall also apply to default in the making of the modified payments here under.
 - All covenants, agreements, stipulations, and conditions in the Note and Mortgage shall be and remain in full force and effect, except as herein modified, and none of the Borrower's obligations or liabilities under the Note and Mortgage shall be diminished or released by any provisions hereof, nor shall this Agreement in any way impair, diminish, or affect any of Lender's rights under the remedies on the Note and Mortgage, whether such rights or remedies arise thereunder or by operation of law. Also, all rights of recourse to which Lender is presently entitled against any property or any other persons in any vay obligated for, or liable on, the Note and Mortgage are expressly reserved by Lender.
 - (c) Borrower has no right of set-off or counterclaim, or any defense to the obligations of the Note or Mortgage.
 - (d) Nothing in this Agreement shall be understood or construe 1 to be a satisfaction or release in whole or in part of the Note and Mortgage.
 - (e) All costs and expenses incurred by Lender in connection with this Agreement, including recording fees, title examination, and attorney's fees, shall be paid by the Borrower and shall be secured by the Mortgage, unless stipulated otherwise by Lender.
 - (f) Borrower agrees to make and execute such other documents or papers as may be necessary or required to effectuate the terms and conditions of this Agreement which, if approved and accepted by Lender, shall bind and inure to the heirs, executors, administrators, and assigns of the Borrower.
 - (g) Borrower agrees to pay Lender a service fee of <u>One Thousand Two</u> <u>Hundred Dollars (\$1,200.00)</u> for fees and expenses incurred by Lender in connection with this Agreement.
